AWESOME By Tom Campion

That is the expression my granddaughter Ashlee, uses to describe something that she thinks are fantastic, terrific and satisfying. Ashlee is the daughter of my oldest daughter and son-in-law, Roslyn & Ronnie Bartee. She has just completed her junior year at Foster High School in Richmond, Tx., and is very active in extra-curricular activities at school - the school choir, cheerleading team, and a member of the FFA. After two years on the cheerleading team, she has been appointed head cheerleader. In FFA she is also very active, raising a Brahman Heifer called Thumper. Two years ago Thumper finished second in a competition at the Houston Livestock Show. Thumper received a red ribbon and it was "AWESOME" One thing for sure, Thumper is not going to live up to her name.

Several months before school ended, Ashlee asked me if I knew anything about 'The Great Depression of the 30's & 40's'. I told her that I was born during the Depression. Evidently, her History class was studying that period and she asked me if I would talk to her class about the DEPRESSION. I said that I would be glad to. About two weeks before school ended I got the call. We met at her school along with her mother, and I was introduced to her teacher. The class consisted of about 30 students, mostly pretty, young ladies.

I started talking, and told them sometimes I had to put thick cardboard in my shoes to cover the holes in the soles, how the ice man came around and delivered blocks of ice to everyone. "Ice boy" sold blocks in 10, 20, 30 & 50 cent sizes. For a little humor, I told them how I had to walk barefoot, 2 miles in the snow uphill, both ways. That got everyone to pay attention and smile. I explained what I knew caused the Depression: the bank failures and unemployment that were nearly 20 % of the countries workforce, as compared to 8% at the present time. When the Depression came to an end in 1939, it was believed Pres. Roosevelt ended the depression with his creative government jobs. For many that may have been true, but I believe that WWII helped end it. All the factories geared up to make military materials, (Rosy the Riveter) and men went into the Army.

At that point, the teacher noticed that I had my KWV shirt on, and asked me to talk about the Korean War. I told them how and why the war began, all the students appeared to be interested, and asked me questions about my experiences there and a little about my personal life. After about 45 minutes I told them to remember -Freedom Isn't Free.

When I finished my talk, everyone applauded and the teacher thanked me

Ashlee told me that I was "AWESOME" and that all the other speakers were boring and put everyone to sleep. She said everyone was listening attentively and asking questions.

JULY 27th PRESIDENTIAL PROCLAMATION

Signed July 24, 2009

Fifty-six years after the signing of the Military Armistice Agreement at Panmunjom, Americans remain grateful for the courage and sacrifice of our Korean War veterans. More than 600,000 United States and allied combatants lost their lives in Korea during the 3 years of bitter warfare that ended on July 27, 1953. Many were also injured, taken as prisoners of war and missing in action. These dedicated servicemen and women, under the banner of the United Nations, fought to secure the blessings of freedom and democracy on the Korean Peninsula, and they deserve our unending respect and gratitude.

Today we remember and honor the valor of Korean War veterans and the extraordinary sacrifices that they and their families made in the cause of peace.

NOW, THEREFORE, I, BARACK OBAMA, President of the United States of America, by virtue of the authority vested in me by the Constitution and the laws of the United States, do hereby proclaim July 27, 2009, as National Korean War Veterans Armistice Day.

VETERANS CORNER

Wounded Veterans Get Tax Break:

Under legislation signed by Gov. Rick Perry last month, severely injured veterans are about to get some major financial relief: They will no longer have to pay property taxes on their homes.

Disabled veterans in Texas will qualify for total homestead property tax exemptions if the Department of Veterans Affairs has determined they are unable to work or they are receiving 100 percent disability compensation for physical or psychological problems related to their military service.

The new law also increases exemptions for veterans with disability ratings of 30 %, 50% or 70%. Many states offer similar tax breaks. For more information contact the Department of Veterans Affairs at 1-800-827-1000.

NEW LAWS EFFECTIVE SEPTEMBER 1st

Did you know beginning September 1st that **ALL** occupants of a vehicle must wear a seatbelt or that using a cell phone in a school zone is illegal?

HB 537 requires <u>all</u> occupants of a vehicle, no matter their age, to be secured by a safety belt, no matter where they are seated in the vehicle;, changes the definition of a passenger vehicle to include a passenger van designed to transport 15 or fewer passengers including the driver. This bill also prohibits a motorcycle operator from carrying a passenger under the age of 5 unless the child is seated in a sidecar attached to the motorcycle.

HB 55 makes it illegal to use a wireless communication

device in a school zone unless the vehicle is stopped or a hands-free device is used. Cities or counties wanting to enforce this law must post a sign at the beginning of each school zone to inform drivers that using a wireless communications device is prohibited and the operator is subject to a fine. It is a defense to prosecution if the operator was making an emergency call.
